### 2021 Release Form

I, the undersigned, hereby waive, release and discharge any and all claims for damages for death, personal injury or property damage that I may have, or that may subsequently accrue to me, against KXVA FOX West Texas Abilene, TEGNA Inc. and all 2021 Abilene Christmas Lights Parade (the "Parade") promoters, sponsors and any involved municipalities or other public entities, and the respective affiliates and subsidiaries and the respective directors, officers, employees, agents, successors and assigns of the above-referenced entities, as a result of my participation in the Parade.

I consent to the broadcast or publication, without limitation or compensation, of my name, biographical information and likeness in any media for any purpose, including any commercial or promotional purpose.

Further, I hereby agree to indemnify, defend and hold FOX West Texas Abilene, its parent, subsidiaries and affiliates, and their respective officers, directors, employees, agents, successors and assigns, and all Parade promoters, sponsors and any involved municipalities or other public entities and any of their respective affiliates and subsidiaries and their respective directors, officers, employees, agents, successors and assigns harmless from and against all actions, suits proceedings, judgments, demands or claims (whether valid or invalid), liabilities, losses or expenses whatsoever (including reasonable attorneys' fees) incurred in connection with or arising out of (i) any injury to myself or my property and (ii) any injury to the person or property of any persons other than myself due to my participation in the Parade.

I further agree and covenant that I will not file suit or authorize anyone else to file suit in connection with any claims that I may have against FOX West Texas Abilene, TEGNA Inc. or any of its affiliates or subsidiaries, or any of their respective directors, officers, employees, agents, successors and assigns arising out of any injury to myself or my property as a result of my participation in the Parade.

I hereby acknowledge that I am knowingly, willingly, freely and voluntarily participating in the Parade. I further acknowledge that the sponsors have informed me of the risks associated with my participation of the Parade, including serious injury and death, and I acknowledge that I understand and hereby assume these risks.

I acknowledge it is my sole responsibility to consult with my personal physician before commencing participation in the Parade and warrant that I had the opportunity to consult with a physician regarding the risks arising from such participation and promotion.

It is further understood and agreed that this waiver, release, hold harmless and assumption of risk is to be binding on my heirs and assigns.
